Structure and Composition The cap is made of 35-40gSMS, with ties for fixing. Intended use The products are mainly used for general isolation in outpatient clinics, wards, inspection rooms, cleaning room, laboratory etc. It is intended to be used by healthcare professionals in hospitals and clinics to maintain a good level of hygiene and contribute to infection control.

Contraindication The products can be used only once and should be used immediately after opening the package. If the package is damaged, the product is wet or moldy. Don't use them.

#### How to use the product

1. Open the product package and take out of the cap, and squeeze the ends of the cap with both hand.

Storage It should be stored in a clean room with relative humidity not exceeding 80%, no corrosive gas, stored in a cool, dry and well ventilated.
