

TAVOLA SPINALE SPINAL BOARD PLANCHE DORSALE TABLERO ESPINAL





This product is made of high density PE material by one-step molding. There are two carbon fibre reinforced plastic stays which makes board strong.

The spinal board is used for transferring spinal injury patient, also used as normal stretcher.

# Warning!

The product should be practiced by trained persons. The patient should be moved and carried by trained persons, or damage may occur.

## **OPERATION**

- 1. Place the product on flat ground.
- 2. Move the patient on the product in the right way.

3. Unlock the fixed straps, and thread one side of strap through the handle hole of spinal board, and lock the straps one by one.

4. The spinal board has handles on the edge. After be sure the patient is fixed well, the patient can be moved both frontward and backward or rightward and leftward.

## CLEANING

Wash with water and soap or bactericidal liquid
