# **CORESCRUB WITH CHLOREXIDINE 4%** (at 20% concentration)

Scrub brush / with sponge used for hand cleansing disinfection.

#### Description

Scrub brush with antiseptic solution, single use, used for hand and forearm disinfection of sanitary personnel. Contains 20 ml antiseptic soap solution and ail cleaner.

### **Indications**

Device made off a nylon scrub brush, a sponge glued at the base and comes provided with a nail cleaner. Used for disinfection of sanitary personnel and surgeons' nails, fingers, hands and forearms, participating in surgery. Exclusively for external use and on healthy and unhurt skin. Used in preoperative areas only.

### Precaution

Avoid contact with eyes. Do not swallow. Do not use any package which presents defect sealing. DO NOT USE ON ANY OTHER PARTS OF THE BODY WHICH ARE NOT INDICATED IN THE PRESENT FILE.

### **End-user**

Operating room, Urgency, Reanimation centres, dentists,...

#### Warehouse

To be protected from humidity and direct exposure to sunlight and at room temperature. Must be stored in clean environmental areas as by local regulation.

### **Instructions of use:**

- Open the individual wrapping, where written; "open"
- Use the antiseptic solution and distribute soap solution equally on hands. Use the scrub only for nails and between fingers. Use the sponge for the skin areas.
- Brush and use sponge to disinfect starting from fingers, ending before reaching elbows. Take special care of areas between fingers and nails.
- Clear hands and forearms with running water holding up hands always higher then elbows. The entire procedure lasts 5 minutes.
- Discard scrub brush after use, as by residual protocols and local law application.
