INTRODUCTION

The economic examination bed was designed for use in hospitals, community facilities and nursing homes; it is particularly suitable for medical centre/clinic use.

Pursuant to Directive 2007/47/EC, the bed falls within the CLASS I MEDICAL DEVICES.

DESCRIPTION OF THE PRODUCT

The bed has small dimensions; the mattress, washable and flame-retardant, consists of two parts, a first part that is fixed and a second part that can be reclined into a variety of positions.

Components

- No. 2 legs
- No. 1 cross-piece with raise backrest
- No. 5 cross-pieces
- Backrest padding
- Seat padding

INSTRUCTIONS

The bed is supplied completely disassembled

- 1. Take the 2 legs and start by securing the cross-pieces, including the cross-piece with with raise backrest, using bolts.
- 2. Lastly attach the padding to the frame using screws.

- Check that the nuts locking the legs are tightened properly.
- Periodically check all fixing points.
- Clean the mattress with a damp and soapy cloth and rinse well with clean water.
- Do not use solvents, bleaches and chemical cleaners or sprays for polishing.
- Clean the bed without using abrasive products. Dry with care.
- If disinfection is required, only use suitable non-corrosive products.
- Only use original spare parts.

- The bed comes with a two-year warranty for material and manufacturing defects, but does not include consumables.
